Agenda Language:

- A. Approve twelve-month extension (Modification No. 3) to Contract No. 11T00034OJ, Key & Piskuran Insurance Agency, for property and boiler/machinery insurance; and
- B. Reject terrorism coverage under the Terrorism Risk Insurance Act of 2002 (TRIA), and authorize the County Judge to sign the TRIA Policy Disclosure Statement.
- Ø Purchasing Recommendation and Comments: Purchasing concurs with department and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes.

Purchasing concurs with HRMD's recommendation to exercise its first option to renew the contract with Key & Piskuran Insurance Agency, and with Affiliated FM as the underwriter. The renewal rate will be a flat rate renewal. Although the rate charged per \$100 of value will remain the same, the actual premium will vary from last year due to an increase in property values and/or from purchased or sold properties. The estimated premium is \$390,686.00, which includes engineering services to be provided by Affiliated FM. The Risk Management Office does not recommend the optional TRIA coverage.

This Modification No. 3 will extend the contract for the property and boiler/machinery insurance with Key & Piskuran Insurance Agency for an additional twelve months, from January 1, 2012 to January 1, 2013.

Modification No. 2 added the SMART facility to the contract, effective August 23, 2011. The contract amount was increased by \$519.00, to


\$389,870.00. The Purchasing Agent signed the modification on October 7, 2011.

Modification No. 1 deleted a facility (5335 Airport Boulevard), and added a facility (4717 Heflin Lane), to the contract. The premium increased by \$8.00, from \$389,343.00 to \$389,351.00. The Purchasing Agent signed the modification on April 14, 2011.
