procurement action meets the compliance requirements as outlined by
the statutes.

This contract is for County wide refuse collection services. Commissioners Court approved the award of this contract on December 21, 2010. This modification will extend the contract for an additional twelve (12) months from February 1, 2012 through January 31, 2013.

Modification no. 3 was previously issued to change the frequency of service at the SMART Facility in Del Valle effective October 18, 2011. This was approved by the Purchasing Agent on November 7, 2011.

Modification no. 2 was previously issued to add an additional 8 cu. yd. container at the Correctional Complex in Del Valle effective March 16, 2011. This was approved by the Purchasing Agent on March 24, 2011.

Modification no. 1 was previously issued to delete a location at the Correctional Complex in Del Valle effective February 1, 2011. This was approved by the Purchasing Agent on February 24, 2011.

Contract Expenditures: Within the last 12 months \$208,367.03 has been spent against this contract.


