AGENDA LANGUAGE:

BACKGROUND/SUMMARY OF REQUEST AND ATTACHMENTS:

On May 1, 2012 the Commissioners Court proclaimed May 6th - 12th "Public Service Recognition Week" and May 8th as "Travis County Employee Recognition Day".

On this day – May 8th – Travis County Employee Recognition Day – the Commissioners Court recognizes 177 employees whom, through their dedicated service, have achieved the milestones of 20, 25, and 30 years of service during 2011. Collectively, the 177 employees represent 3,965 years with Travis County, with an average of 22.4 years.
