- ➤ Travis County Facilities Management (FM) Department, with Purchasing's concurrence, requests Commissioner Courts' approval to reject the sole bid for IFB No. B120133-LP, form Cohesive Automation, Inc., for \$370,000.00. The sole bid was \$270,000.00 or 270% over the \$100,000.00 estimated budget.
