AGENDA LANGUAGE:

Consider and take appropriate action to 1) approve membership dues of \$300.00 for two memberships in the Texas Affiliation of Affordable Housing Providers; and 2) approve registration fees of \$790 for two attendees to the Texas Housing Conference held in Austin, Texas July 23 through July 25, 2012 to be paid for by the Corporation.

BACKGROUND/SUMMARY OF REQUEST AND ATTACHMENTS: The Texas Affiliation of Affordable Housing Providers (TAAHP) is a non-profit 501(c)(6) trade association serving affordable housing industry providers. Their principal goal is to increase the supply and quality of affordable housing for Texans with limited incomes and special needs.

Founded in 1997, TAAHP is considered the "Voice of Affordable Housing in Texas," and represents housing industry professionals involved in the financing, design, development, and management of affordable housing communities in Texas.


