SUBJECT: Travis County Bee Cave Road District No. 1 Property Tax Exemptions

In light of the current discussion on proposed changes for Travis County's Historic and Over 65 and Disabled exemptions, we postponed recommendation for the Travis County Bee Cave Road District No. 1's exemption policy. However, as it is the Road District's current policy to offer no optional exemptions, we recommend the Court retain the current policy regardless of the outcome of the discussion on the County's exemptions, and adopt the following parameters for the Road District:

- A. Optional Homestead Exemption: No exemptions
- B. Over 65 and Disabled Optional Homestead Exemptions: No exemptions
- C. Historic Exemptions: No Exemptions
