AGENDA LANGUAGE: Consider and take appropriate action on a request to close Old Lockhart Highway between Thaxton Road and Carl Road for culvert replacement beginning July 18, 2012 through August 17, 2012 or until construction is completed in Precinct Four.

BACKGROUND/SUMMARY OF REQUEST AND ATTACHMENTS:

There is an existing drainage structure under Old Lockhart Highway just south of Thaxton Road that has deteriorated and needs replacement. In order to replace the existing drainage structure, the roadway will have to be closed for approximately 4 weeks. All local traffic will still have access during construction.

STAFF RECOMMENDATIONS:

Staff recommends that Old Lockhart Highway between Thaxton Road and Carl Road be closed to through traffic from July 18, 2012 through August 17, 2012 or until construction is completed.
