
Agenda Language: APPROVE ORDER EXEMPTING THE PURCHASE OF INTERNATIONAL, IC CORPORATION, MERITOR AND HALDEX OEM PARTS AND SERVICE FROM LONGHORN INTERNATIONAL TRUCKS OF AUSTIN FROM THE COMPETITIVE PROCUREMENT PROCESS PURSUANT TO SECTION 262.024 (A)(7)(D) AND SECTION 262.024 (a)(11) OF THE COUNTY PURCHASING ACT.

➤ Purchasing Recommendation and Comments: Purchasing concurs with department and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes. The Exemption Order will be for the purchase of International, IC Corporation, Meritor and Haldex service and OEM parts necessary to complete repairs for the Transportation and Natural Resources Department.

Transportation and Natural Resources requests the ongoing purchase of International, IC Corporation, Meritor and Haldex OEM parts and services to be used with the existing International, IC Corporation, Meritor and Haldex equipment now in use. Purchasing request the Commissioners Court approve an Exemption Order to exempt International, IC Corporation, Meritor and Haldex OEM parts and service from further competition and allow the Purchasing Office to issue purchase orders to provider, Longhorn International Trucks of Austin.

Local Government Code 262.024(a)(7)(D) allows for exemption from the competitive purchasing process any item that can be obtained from only one source, including captive replacement parts or components for equipment. Local Government Code 262.024(a)(11) allows for exemption from the competitive purchasing process vehicle and equipment repairs.

ORDER EXEMPTING PROCUREMENT OF INTERNATIONAL, IC CORPORATION, MERITOR AND HALDEX PARTS AND SERVICE FROM REOUIREMENTS OF THE COUNTY PURCHASING ACT

WHEREAS, the Commissioners Court of Travis County, Texas has received a Sole Source Justification from Travis County Transportation and Natural Resources in accordance with TEXAS LOCAL GOVERNMENT CODES, 262.024 (a)(7)(D) and 262.024 (a)(11) and

WHEREAS, the County desires to enter into a contract with Longhorn International Trucks of Austin to provide Navistar Parts Group, parts and service. Navistar Group manufactures genuine International, IC Corporation, Meritor and Haldex OEM parts.

NOW, THEREFORE, the Commissioners Court of Travis County hereby orders that the purchase of International, IC Corporation, Meritor and Haldex, parts and services from Longhorn International Trucks of Austin be exempted from the requirements of the County Purchasing Act for competitive proposals pursuant to TEXAS LOCAL GOVERNMENT CODES, 262.024 (a)(7)(D) and 262.024 (a)(11) as these items are captive replacement parts for vehicles and equipment and repair services provided by certified technicians.
