AGENDA LANGUAGE:

In accordance with the Travis County Policies, Procedures and Regulations Manual, Sections 10.043 Holidays and 10.044 Personal Holidays, respectively, discuss and approve Holidays effective October 1, 2012 through December 31, 2013.

BACKGROUND/SUMMARY OF REQUEST AND ATTACHMENTS:

The Commissioners Court sets the Travis County holiday schedule during the budget process each year for new fiscal year and the remainder of the following calendar year, in accordance with Travis County Policies, Procedures and Regulations Manual, Sections 10.043 and 10.044.

Travis County has allowed employees eleven (11) designated paid holidays and three (3) personal holidays each year since at least FY2005. Designated holidays are set on the actual date of the holiday, unless the actual date falls on a Saturday or a Sunday, in which case the holiday is observed on either the Friday before or Sunday after the actual holiday.

Our peers (including City of Austin, Bexar, Dallas, Harris, Tarrant, and Williamson Counties) have consistently observed between 10 and 12 holidays per year.

STAFF RECOMMENDATIONS:

Staff recommends approval of the attached holiday schedule, which observes eleven designated holidays for FY2013.
