

ORDER APPOINTING COUNTY AUDITOR

Pursuant to Chapter 84, Subchapter A, of the Texas Local Government Code, on this day, meeting specially to appoint the County Auditor of Travis County, a majority of the District Judges of Travis County do hereby appoint Niccoli "Nicki" Riley as the County Auditor of Travis beginning September 1, 2012. The annual salary of the County Auditor shall be set at \$165,000 plus up to the 3.5 percent increase granted March 27, 2012, by Travis County Commissioners' Court. If the Travis County Commissioners' Court grants additional compensation to the county workforce for Fiscal Year 2013 including both ongoing and one-time, the County Auditor is hereby authorized to receive the same percentage increase at the time specified by Commissioners' Court for the award. Before Niccoli "Nicki" Riley begins to serve as County Auditor, she shall take the proper oath as prescribed by law and shall execute a bond in the amount of \$5,000.00 as provided by law.

The District Clerk shall record this action in the minutes and certify it to the Commissioners Court.
