Dear Mr. Eric Miller:

I received your email dated, Oct. 30, 2012, regarding the Travis County Uniform Bid, and below are my responses to your concerns and comments.

<u>Concern #1: Quality of Uniforms:</u> You believe that the Flying Cross/Fechheimer uniforms are of equal quality to the Blauer uniforms. In addition to our own wear test done several years ago, we have other data showing the differences in material and craftsmanship. Our information shows that Blauer is a leader in providing law enforcement uniforms and is superior to your product.

The solicitation (page 54) informed bidders of our wear test results and acceptable uniforms: "The Travis County Sheriff's Office conducted a wearability test to determine the uniform shirts and trousers specified in this solicitation. The Blauer shirts and trousers as described in paragraphs A through E were selected as a result of the wear test. The uniform required by the Sheriff's Office for Honor Guard is described in paragraphs F and G. No exceptions or substitutions will be allowed for items described in Paragraphs A through E. Any bidder bidding other than Blauer for these items will be considered nonresponsive. Other County departments and Constables also purchase Blauer, and Horace Small models not listed specifically below. A discount from manufacturers MSRP is requested for Blauer and Horace Small for all items not listed."

The Feichheimer items were added at the request of the SO as additional line items and were added in groups N, O, P, Q, R. These added items did not replace any of the Blauer items in groups A through E. After bid opening, the Sheriff's Office decided not to award items N. O. P. Q. R and Y.

Concern #2: Request for local service site: Our needs and specifications require a local servicing site located in Austin, TX. Bid states, "Contractor must have, currently established, a physical place of business located in Austin, Texas. Uniforms are expected to be in stock at contractor's site within thirty (30) days after the award of

contract. "Altered from stock" items are required to be provided within 3 - 5 days of an officer's fitting. Made-to-measure items are required to be provided within 30 days of an officer's fitting. Stock items are expected to be available to officer/personnel upon fitting. Fittings can be arranged/scheduled by phone in advance of an officer's arrival by the Travis County Sheriff's Department. Officers will appear at contractor's site with written authorization for number/type of uniforms. Pants are to be hemmed while the officer waits and contractor shall provide adequate seamstresses to provide this service. It will be the responsibility of the contractor to determine if alterations are required within the guidelines of paragraph "Z".

Additionally, to allow fair competition we added, "KK. Bidders located outside Travis County will be required to have a local service site located in Austin, Texas to provide the services of this contract. Failure to provide a local service site with this bid will render the bid non-responsive. Indicate below the local service site and name and telephone of individual to contact." Therefore, any firm willing to provide this service locally would be allowed to bid.

Concern #3: Excessive Prices: You believe that Travis County is paying excessive prices for our law enforcement uniforms from our current and recommended contractor. In my analysis, I do not believe we are paying excessive prices. In fact, we looked at similar agencies and we are paying less than or equal pricing for our Blauer uniforms compared to other public entities. I will agree with you that we are paying more for the Blauer uniforms than the Flying Cross, however, we are able to wear our uniforms longer than other departments wearing Flying Cross. Therefore, I would argue that our overall cost are lower over the years. Additionally, the quality of service we have historically received from Miller Uniforms has been outstanding. Lastly, this is a high maintenance contract, meaning we have officer's walking in any day of the week ordering uniforms and requesting alternations, sewing on patches, and more.

Governments have finally realized the value of "total cost" and "best value" purchasing. Although we pay a little more for a quality uniform, it last longer and our officers feel more comfortable in their daily jobs.

Comments and opinions not based on facts can often result as being slanderous. Many of the comments, opinions, and accusations by Eric Miller, who is not even a Travis County taxpayer, are simply not true. To follow you will find some facts:

Currently, we are listed on a bid for the Travis County Sheriff's Office alongside our competitor, Blauer. – Not true. The bid package clearly states that Blauer is the core uniform wear tested and desired by the TCSO. The few select Fechheimer items were added last minute due to bidding time constraints and for some form of evaluation/comparison purposes only. Only 50pcs. of each of these items on the bid kind of gives that away.

Both Blauer and Flying Cross offer equal quality garments: Another false statement.. They by no means are an "apples to apples" comparison. After 30 to 40 years of wearing the likes of Flying Cross by Fechheimer, Elbeco, Horace Small, and Perfection, back in 2007-2009 the Texas Department of Public Safety (almost 3000 Troopers in uniform) conducted a multi-year wear test and Blauer unanimously stood above all manufacturers. In April of 2009 we were awarded a multi-year contract from the State of Texas to provide these uniforms in a service fashion very similar to that of TCSO. Feel free to contact Major Ron Joy (512-424-2115) at the Texas DPS to back up this fact. Like the TXDPS, the TCSO conducted a similar wear test (maybe not as large or as long) with a similar result. Garments not being replaced as frequently because of their superiority actually provides a better value purchase. Less expensive inferior garments can only provide a first year short term savings as these will require much more frequent replacements, therefore resulting in more monies spent over the long haul. So there's definitely value in buying the superior quality and inferior garments will only end up costing the County more over time. See attached "Blauer Difference" brochures for numerous detailed differences but specifically here are some key important specification facts:

Fechheimer Shirts/Pants <u>versus</u> Blauer Shirts/Pants: **SHIRTS**: Fech: 9-9 ½ oz. Single-Ply Wool with no Mechanical Stretch, Blauer: 10 ½ oz. Two-Ply Wool With Mechanical Stretch. **PANTS**: Fech: Poly/Wool 11 ½ - 12 oz. Single-Ply with no Mechanical Stretch and Poly/Rayon 11-11 ½ oz. with <u>Lycra</u>, Blauer:

14.5 oz. Two-Ply Poly/Wool With Mechanical Stretch and 15 oz. Two-Ply Poly/Rayon With Mechanical Stretch. The 1st brochure explains in detail about the advantages of having Mechanical Stretch in garments and also goes into detail about other key features Fech does not use such as Fusible Interlinings, Self Healing Nylon Zippers (Fech uses Metal zippers-Nylon Zippers are found in highend male and female clothing), Triple Bar Tacking, etc., all of which make Blauer garments last longer and maintain better appearance. Please note that Lycra (a chemical form of stretch that breaks down over time) is only in the Poly/Rayon Fech pants-**no other** form of Stretch is in any of the other Fech items quoted. Please also note the lighter fabric weights make the Fech garments simply lighter and cheaper. In addition to the Two-Ply fabrics let me also add that Blauer is the only manufacturer the uses Long Staple Wool versus Short Staple Wool. Long Staple Wool is woven from longer stronger higher quality fibers and materials in the weaving process. Long Staple is comparable to the Cashmere level of quality. The shorter weaker fibers that break off during this process are what is referred to as Short Staple Wool. All of Blauer's competitors choose to use this less expensive alternative in their wool/rayon blends as a cost savings. Blauer only chooses to use the best fabrics and components to ensure the highlest level of quality available in the industry. By using the highest level of quality components this allows for the garments to have the best wearability as well as longevity which again translates to best overall value.

The bid originally listed for there to be no substitutions on Blauer items. However, because Fechheimer met the quality standards that Travis County Sherriff (TCSO) was looking for, Flying Cross was added on behalf of TCSO to bid on the contract. – Simply another false statement

The purpose of this email is to provide you with the pertinent details of the current bid and to reveal what appears to be some considerable price discrepancies. I feel that there has been a significant oversight: This is simply not true. There has been no "significant oversight" or "overage of \$333, 615.15" paid by the County. The differences in our bid prices does not mean or reflect that the County has ever over paid for anything. The usages on the bid package are merely estimates that are simply over-inflated. Two examples of this would be Blauer Item #8460/8460W-Short Sleeve Class B Shirts (4410pcs.-and the 1st 14/Line Items of the bid) and the Blauer Item #8560/8560W Class B Pants (3970pcs.-and only 12/Line Items). We wish you bought these types of quantities. The extended bid total of just these two items on our bid (without over size/made to measure charges or any other bid items) comes to a total of \$581,530.00. This is only two items! Here's one more...Blauer Item #8560/8560W Class A Pants (1175pcs. and only 5/Line Items) comes to a total of \$93,412.50! Class A Pants typically only get issued to new hires. And also please note that the addition to the bid package of 12/Line Items of Supershirts and 6/Line Items of Streetshirts will replace the usages of the 1st 14/Line Items (#8460/8460W Class B Short Sleeve Shirts), not to mention the 9/Line Items of Fechheimer items which continues to add to the over inflation. In 2010 the TCSO bought from Millers approximately \$375K in total uniforms/outerwear and additional items/accessories/patches not on this bid, in 2011 that figure was approximately \$452K, and Year To Date for 2012 is \$393,312.00...but the claim is the County has an over-age of \$333,615.15 a year and possibly 3 years total overage of \$1,000,845.45 paid by county tax payers? Creating these comments/statements and accusations from simply looking at a bid submission is absolutely false and ridiculous! As far as the differences in our prices relative to the other bidder: Miller Uniforms has been providing a level of service that this contract calls out for, for nearly 28 years. This service includes heavily stocking the product, providing a while-u-wait service so that the end user walks in with an order and walks out with their uniforms, and an extreme amount of custom tailoring. This can only happen with an adequate staff and the infrastructure to support it. This staff includes 12 seamstresses/tailors, 10 floor(5)/floor support(5) staff, not to mention the additional 13 support staff behind the scenes. We've been doing this a long time and we clearly know what it takes and what kind of a margin of profit that is required to make sure we can adequately support this kind of contract for years to come. With all due respect to GT Distributors, a fine company, we sincerely believe they may not understand the actual level of custom alterations that will be required or maybe they have been mislead by their Fechheimer rep in this area. If their prices came in a lot lower than ours we can only assume that's just a lack of experience and history with the TCSO uniform purchases which is no fault of theirs. Actually, percentage-wise, the custom alterations are actually underestimated in this bid. I'd be happy to go into more detail here and/or refer to a previous email dated 08/27/12. As I said, we've been doing this a long time and are proud to have an impeccable reputation for carrying the best products in the industry along with providing the best service in the industry.

Problem #1: I feel that it should be noted that Miller Uniforms has taken clear advantage of TCSO. False again...It's very disheartening to see a manufacturers rep (let alone our manufactures rep) drag our outstanding reputation through the mud just to "make the sale". It would be disheartening to see any manufacturers rep do this to any company, let alone one with our kind of reputation that we've worked so hard for so long to maintain. Miller Uniforms has always and will continue to always look out after the best interest of our customers. You don't stay in business as long as we have and have held this good of a reputation for as long as we have by taking advantage of anyone. It's unfortunate that we should have to take the time out of our busy schedule to defend a reputation that really speaks for itself but unfortunately we find ourselves having to do just that.

Problem #2: Another false statement that there was a true wear test of Fechheimer garments. The County does not have to justify or substantiate why Blauer is superior because they had already conducted a real wear test, made conclusions, and put together a bid package that was in their best interest.

We don't believe the County is about to make a "silly \$1 million mistake" just because. This comment by Eric Miller is ludicrous!

In addition to the Texas Dept. of Public Safety to follow you will find a list of only some of the agencies we are under contract with Blauer products and service requirements similar to that of the TCSO. The County is welcome to copies of any of these bid packages for their review and comparison along with any contact information you may desire as well. All of these agencies have graduated up to the superior Blauer quality.

Bob,

See attached email that Eric Miller sent to Commissioners Court Agenda.

To Whom It May Concern:

My name is Mary Moskovitz and I represent Blauer Manufacturing.

I am writing in response to the allegations and false statements made by our competitor Eric Miller with Fechheimer. Eric Miller has written a letter to protest the recent bid from August of 2012 in which Blauer products were specified and chosen by Travis County Sheriff's office. My response to these false and misleading allegations will be kept factual in order to provide TCSO with the justification requested to defend the process that was completed in order to choose these items.

- Eric Miller alluded that Fecheimer products were wear tested and approved by TCSO.
 - Fact: The wear tests conducted by TCSO on the Blauer products specified have been done over several years with officers from various positions and divisions including Patrol, Jail, and SWAT. These WT's have included class A, and B uniforms, polo shirts, jackets, BDU's, outer vest carriers, and rainwear solutions. The results of these WT have been the repeated recommendation, by the officers and the committee put in place, for Blauer products to be the uniform of choice worn by TCSO. These WT's were conducted in comparison to the previously worn Fechheimer products as well as the other brands including Elbeco and Perfection.
 - The WT process alluded to by Eric Miller for Feccheimer was done with only a select few products, (Vertex polo, SS and LS shirt and trouser), and were not conducted in a similar manner to evaluate over time whether the garments suggested performed to the same form fit and function as the garment wear tested from Blauer. These few items were only given to 2 administrative officers and never put into the field for a thorough evaluation. Although the administration did briefly agree to allow these few select items on the bid after a limited wear test, they did so to my understanding, due to time constrainst with the bid and for evaluation and price comparison only. Upon further review and evaluation it is also my understanding that the determination was made by the county that the products were NOT in fact equivalent as Eric Miller stated, but on the contrary. They determined the Fechheimer products to be lesser in quality and comparison, therefore they dismissed them from the bid.
- 2. Eric Miller also alluded to Miller Uniforms and GT distributors as the only bidders, due to the 25 mile radius service requirement specified by TCSO.

- FACT: This type of request and specification is very common and within the legal rights of a large city or county to ensure that the awarded vendor is capable of the on site service and alterations requirements in the bid.
- 3. Eric Miller alluded that Miller Uniforms has in some way taken advantage of this and again has made false statements as a matter of opinion.
 - FACT: Miller uniforms has serviced the TCSO for over 25 years with a proven track record of service and reliability.

All too often it is the unfortunate case in large city and county bids such as this, where agencies are subjected to low bid alternatives whose business model is to chase large city bids in hope to win contracts without any of the resources or past performance criteria needed to substantiate such bids.

- 4. Eric Miller alludes to tax payers dollars being spent irresponsibily with some figures that simply do not add up.
 - FACT: The few select Feccheimer items that were allowed on the bid were
 put on as optional line items only and at the full discretion of the county.
 They were NOT accepted by the county as garments of equal quality or
 performance in the areas of form, fit or function. Therefore a dollar to dollar
 comparision with non approved and non equivalent substitutions as an
 alternative is a false statement.
 - ASSUMPTION: Eric Miller has assumed that the annual volume referenced in the bid are absolute and has alleged that the total dollar amount allocated is a misuse of tax payers dollars.
 - FACT: The numbers used in bids such as this one are simply a guide line for vendors and an estimation of what the county may or may not purchase over the course of the contract. The county is in no way obligated to purchase all items, or spend the entire dollar amount suggested during the bid process.

Eric Miller's allegation of the county spending "over a million dollars in excess" is based on assumption that a select few items would be accepted in lieu of the 8 Blauer items WT'd, specified and chosen by TCSO. This again refers back to his unproven misrepresentation that the Feccheimer products are in any way comparable in quality to the Blauer items specified on the bids.

- 5. In Eric Miller's conclusion he alludes that TCSO made an "unjustified" decision to award to Blauer and to Miller Uniforms "just because", and that he finds it "silly".
 - FACT: As stated above TCSO conducted an extensive WT including all major brands of uniforms, of which the Blauer items specified were recommended and chosen.
 - FACT: I have included a reference booklet titled "The Blauer Difference" in which you will see a built point explanation of the many specified differences in the construction and components used to manufacture the Blauer items chosen. These components and construction qualities are just a few of the determining factors of why agencies continually choose Blauer over all of our competitors.
 - Blauer Manufacturing has been making the highest quality and most protective garments availabe for public safety professionals for three generations and more than 75 years.
 - TCSO has determined that these quality differences in uniforms more than
 justifies their decision to switch to, and maintain the Blauer uniforms as their
 first choice in public safety garments for their officers.

- FACT: I am happy to provide you with a list of like size agencies across the state who have gone through similar wear test processes and procedures comparing Blauer and Fechheimer garments. This list would include agencies such as TX DPS, Austin PD, San Antonio PD, Houston PD, and El Paso Cnty Jail. Smaller agencies also making the switch include Corpus Christi PD, San Angelo PD, Travis Cnty EMS, Garland PD, Arlington PD, and Carrollton PD to name just a few. ALL of which have reached the same conclusion and decided to switch from Fechheimer to Blauer for an overall better fit and better value for their uniform needs. Additional information for contact of these references is available upon request.
- Eric Miller alluded that Miller Uniforms is some way taking advantage of being only one of two dealers available within the 25 mile radius specified and they are using that to their advantage to over charge the county for their products and services.
 - FACT: If needed we would be happy to provide sample bids showing like size agencies whose bids not only specify Blauer garments, they also specify similar service and local vendor requirements. In comparison you will see upon request that Miller Uniforms pricing for poly/wool Blauer uniforms and the service requirements requested are in fact in line with ALL of the other competitive distribution in Texas who are servicing like size agencies with similar products and service requirements.

I am proud to defend the process upheld by TCSO and Blauer for the products and services specified in this bid. We appreciate your business and appreciate the opportunity to set the record straight. If you have any questions regarding the items addressed in this memo, please feel free to contact me at anytime.



To Whom It May Concern,

My name is Eric Miller and I am a current manufactures representative for Fechheimer – a Berkshire Hathaway company whose brands consist of Flying Cross and Vertx. The Flying Cross brand has been outfitting law enforcement and military across our nation since 1842.

Currently, we are listed on a bid for the Travis County Sheriff's Office alongside our competitor, Blauer. There are two distributors listed on the bid including Miller Uniforms (bidding both Blauer and Flying Cross) and GT Distributors (bidding Flying Cross only). Both Blauer and Flying Cross offer equal quality garments. The service is considered of equal standard across both Distributors. The bid originally listed for there to be no substitutions on Blauer items. However, because Fechheimer met the quality standards that Travis County Sherriff (TCSO) was looking for, Flying Cross was added on behalf of TCSO to bid on the contract.

The purpose of this email is to provide you with the pertinent details of the current bid and to reveal what appears to be some considerable price discrepancies. I feel that there has been a significant oversight to keep the

tax payers interests in mind (i.e. going with a specific distributor and brand which in turn creates an over-age of \$333,615.15 a year (1 year contract with (2) 1 year renewal options) over a span of possibly 3 years (a total overage of \$1,000,845.45 paid by county tax payers). This should be deeply considered due to the state of our current economic condition. I am disturbed by this myself, not only as an involved participant in the current bid, but also as a resident of Austin. In my opinion the community and tax payers need to be made aware of this decision.

Here is an overview:

Back in August (2012) Travis County Sheriff formally went out for bid and included two uniform manufactures for their Class A & B uniforms (Blauer & Flying Cross). Currently Travis County Sheriff has a 25 mile radius factor in their bid so only two uniform dealers can actually bid on the contract. Both GT Distributors and Miller Uniforms submitted a formal bid.GT Distributors substituted Flying Cross for all Blauer garments and Flying Cross for the Flying Cross specified garments. Miller Uniforms bid Blauer for the Blauer specified garments and Flying Cross for the Flying Cross specified garments.

Problem #1: Miller Uniforms bid above and beyond GT Distributors for the exact same garments by a total amount of: \$333,615.15. I feel that it should be noted that Miller Uniforms has taken clear advantage of TCSO. And with this said, based on the current recommendation – the tax payers of Travis County will be paying this huge amount more simply "just because" – it shouldn't mean the tax payers should have to suffer.

Problem #2: After a presentation/wear-test of the Flying Cross garments – TCSO elected for the brand to be put onto the formal bid. This was based on their evaluation of the uniforms and of their quality (if not superior to their current uniforms manufactured by Blauer). Sheriff Greg Hamilton personally made the call to purchasing to add FC garments to their existing bid. But, with that said - after the Sheriff himself made the addition to the bid, it was then recommended (after the bid closed) that FC garments be removed from the bid because "they aren't in the best interest of Travis County at this time." In fact, after the bid was closed Travis County recommended to the Commissioners Court to "reject all bids received for Groups N, O, P, Q, R

and Y" (all Flying Cross). So to simplify, it has been suggested that TCSO award the bid to Blauer/Miller Uniforms, even though there is absolutely no justification to substantiate why Blauer is superior to Flying Cross.

In conclusion, in 2012, Travis County raised property taxes already by 6.24% (\$27,637,431). And in addition to the unstable and trying economic challenges of this time, can we really afford to make a \$1mm mistake "just because"? It seems silly to me. And I am certain that other tax payers would be outraged as well. Based on the attached spreadsheet as well as the issues described above, I feel the Commissioners Court has to get deeply involved. Moreover, Miller Uniforms - a company that was mistakenly thought to be considered in doing what is best for their partners as well as the community – has considerably taken advantage of the fact that they are the only Blauer dealer within a 100 mile radius – and as a result, is in turn, pricing their goods much higher than what is considered reasonable and fair. There is no way they can justify a \$1mm difference for the same item/service contract. If they have a response to this – I know that I can prove otherwise.

For your reference:

Attachment #1: This shows the price difference between like for like products by Flying Cross and Blauer to be distributed by GT Distributors and Miller Uniforms in detail. This will prove that the costs associated with the recommended award of the bid are costing tax payers in excess of \$1mm (over 3 years) without justification/substantiation.

Attachment #2: This shows the actual bid itself and what product is specified.
