Agenda Language: Approve Contract Award for Cabling Installation Services, Time and Materials, Contract NO. 4400001421, to the highest Responsive Bidder, RC Data Communications, LLC d/b/a Randall Communications.

Purchasing Recommendation and Comments: Purchasing concurs with department and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes. This contract will provide cabling installation services, which will be utilized for moves, routine additions, changes and cabling infrastructure projects.

On January 25, 2013, Request for Services (RFS) NO. 1301-004-SW was issued through BidSync for Cabling Installation Services, Time and Materials. A total of five (5) bids were received on February 11, 2013, but one bid was disqualified since it did not meet the requirements. After evaluating the solicitations, Information Technology Services (ITS) recommends awarding a contract to the highest responsive bidder, RC Data Communications, LLC d/b/a Randall Communications.

This contract will be for one (1) initial year with three (3) one-year renewal options. The pricing shall remain firm for the period of the contract. The prices shall also remain firm for the option years, except for changes that are industry wide and beyond the control of the contractor. If such changes do occur, it will be the responsibility of the contractor to provide documentation to Travis County substantiating the changes to the bid prices.

Contract Expenditures: Within the last 12 months \$568,924 has been spent against this requirement.

Summary and Staff Analysis:

Four companies submitted bids for equipment and technical support for Cabling Installation Service Time and Materials: RC Data Communications, Titus System LP, P & C Communications, and Black Box Network Services. There were two vendors that were asked to submit a Best and Final Offer (BAFO), RC Data Communications and Titus System LP. Based on the RAW score and bid amount, ITS recommends the award of the RFS to RC Data Communications.
