Subject: Consider and take appropriate action on the appointment of Tracy Bratton to the Travis County Board of Review pursuant to Chapter 71.008 – Fire Code.

The Travis County Board of Review was established pursuant to Chapter 71.008 of the Fire Code that was adopted by Travis County on February 1, 2005. The Board of Review is charged with reviewing recommendations of the Fire Marshal's Office about variances and denials of Building Permits and meets as needed to review these cases.

There is one opening on the Board of Review due to a Member that has served out his appointment no longer wishing to serve on the Board of Review.

The open position on the Board of Review is for a qualified engineer.

Mr. Tracy Bratton is a professional civil engineer, registered to work in Texas. Mr. Bratton is the Senior Project Manager for Bowman Consulting in Austin, Texas. Mr. Bratton has worked on projects in Travis County and is familiar with our permitting process. Mr. Bratton's CV is attached.

I recommend the appointment of Mr. Bratton to the Travis County Board of Review. If appointed, his term will be for four years, expiring April 30, 2017.
