AGENDA LANGUAGE:

Recognize Travis County employees who have completed 20, 25, 30, and 35 years of service during calendar year 2012.

BACKGROUND/SUMMARY OF REQUEST AND ATTACHMENTS:

On April 30, 2013 the Commissioners Court proclaimed May 5th - 11th "Public Service Recognition Week" and May 7th as "Travis County Employee Recognition Day".

On this day – May 7th – Travis County Employee Recognition Day – the Commissioners Court recognizes 160 employees whom, through their dedicated service, have achieved the milestones of 20, 25, 30 and 35 years of service during 2012. Collectively, the 160 employees represent 3,630 years with Travis County, with an average of 22.7 years.
