Agenda Language: Declare a 2002 Freightliner, EMS Ambulance as surplus property and donate to Travis County Emergency Services District No. 2, pursuant to Section 263.152(a)(4) of the Texas Local Government Code.

Purchasing Recommendation and Comments: Purchasing concurs and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes.

On April 30th the Court approved a request from the Purchasing Office to declare certain vehicles surplus property and sell at a public auction: [Item 22](#). The item was approved by the Court. However, subsequent to that approval, the Purchasing Office received a request from the Executive Manager of Travis County Emergency Services and from the President and Chief of Travis County ESD No. 2 (TCESD No.2) to ask that an item be sent to the Court to re-consider a certain ambulance from that original request to instead, be pulled from the auction and be donated to TCESD No. 2.

TCESD No. 2 states that its intention is to evaluate the use of this ambulance as a training unit for fire service personnel, as a limited mobile command unit that could be used for local/county-wide needs, and/or in some other emergency support function.
