WHEREAS, Travis County Commissioners Court approved the Travis County Healthcare District d/b/a Central Health tax rate for Tax Year 2012 at an open meeting of the Travis County Commissioners Court on August 14, 2012;

WHEREAS, the Travis County Healthcare District d/b/a Central Health, at an open meeting of the Central Health Board of Managers, called for a special election to consider a tax rate for Tax Year 2013 on August 15, 2013 in accordance with Texas Health and Safety Code §281.124 and the Texas Election Code;
