Agenda Language: DECLARE CERTAIN CARDIAC MONITORS, BATTERY SUPPORT SYSTEMS AND AMBULANCE COTS AS SURPLUS PROPERTY AND APPROVE SALE TO THE CITY OF AUSTIN EMERGENCY MEDICAL SERVICES DEPARTMENT, PURSUANT TO SECTION 263.152(A)(1) OF THE TEXAS LOCAL GOVERNMENT CODE.

Purchasing Recommendation and Comments: Purchasing concurs and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes.

This is a request and recommendation by Travis County Emergency Services (TCES) and Austin/Travis County Emergency Medical Services (A/TCEMS) to pursue a best-value option for the purchase of new cardiac monitors by including used equipment as trade-in.

With Court approval of this request, TCES will sell the equipment (listed below) to the City of Austin Emergency Medical Services Department, which will then in turn, trade-in the used equipment toward the purchase of new equipment. The cardiac monitors and battery support systems are almost 10 years old and are all considered low value assets. However, the two ambulance cots are active capital assets purchased in 2011 with a current net book value of \$9,639.32 each.

Our EMS partners at the City of Austin concur in supporting this recommendation, as the current cardiac monitors are at the end of their useful service life, but still have monetary value as part of a trade-in arrangement. The purchase of new cardiac monitors is expected by A/TCEMS before the end of this year. By including the items listed above as trade-in with the purchase of new equipment, the resulting EMS savings will be at least \$60,000. The budgetary cost to Travis County will be zero.
