Agenda Language: Approve list of Auto-Renewal Interlocal Agreements and Contracts (348 Total) for various services.

- **Purchasing Recommendation and Comments:** Purchasing concurs with departments and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes.

Attached for Commissioners Court approval (Attachment A) is a list of agreements and contracts containing provision for automatic renewal for the period of October 1, 2013 through September 30, 2013. No modifications or other actions are required for this renewal. The renewals are automatic, unilateral, and may be renewed at the discretion of Travis County for successive one-year periods under the same prices, terms and conditions as the original contract.
