BACKGROUND/SUMMARY OF REQUEST AND ATTACHMENTS:

NEED APPROVAL TO USE SIEZED FUNDS TO PURCHASE LAW ENFORCEMENT EQUIPMENT AND SUPPLIES.

David,

The certification section of the Stat Forfeited Reporting form changed in FY13. The new form eliminated the County Judge, Mayor or City Manager signature and now request a signature from the Auditor, Treasurer or Accounting Professional, see samples attachments. The signature affirms that an audit has been conducted as required by Article 59.06 of the Code of Criminal Procedure. I included the statute below. According to correspondence that I received from the office of the Attorney General, the report is due 30 days after the end of the fiscal year. In the past, we filled out the forms, had them signed by the elected officials

and by the County Judge prior to submission. We did not wait for an Audit. How should we proceed this year and should the reports be signed by the Auditor or should they be signed by me or by one of my staff members?

59.06(g)(1) All law enforcement agencies and attorneys representing the state who receive proceeds or property under this chapter shall account for the seizure, forfeiture, receipt, and specific expenditure of all the proceeds and property in an audit, which is to be performed annually by the commissioners court or governing body of a municipality, as appropriate. The annual period of the audit for a law enforcement agency is the fiscal year of the appropriate county or municipality and the annual period for an attorney representing the state is the state The audit must be completed on a form provided by the fiscal vear. attorney general and must include a detailed report and explanation of all expenditures, including salaries and overtime pay, officer training, investigative equipment and supplies, and other items. Certified copies of the audit shall be delivered by the law enforcement agency or attorney representing the state to the attorney general not later than the 60th day after the date on which the annual period that is the subject of the audit ends.
