AGENDA LANGUAGE: Consider and take appropriate action the total vacation of Live Oak Acres Subdivision, Thomas Springs Road - 3 Lots. City of Austin Limited Purpose ETJ and full purpose jurisdiction in Precinct Three.

BACKGROUND/SUMMARY OF REQUEST:

The applicant proposes to totally vacate the recorded subdivision, Live Oak Acres. The land will be replatted into a new subdivision, Preserve at Thomas Springs Road. This vacation request needs to be approved prior to, or concurrently with the court's approval of the new final plat for the Preserve at Thomas Springs Road.




