Additional Backup for 12/10/13 Agenda Item #22 (Travis County Organization Review & Assessment)

Proposed third-party organizational review and assessment:

- 1. To evaluate our current organization and structure.
- 2. To evaluate our current lines of authority and business processes.
- 3. To provide us with findings and recommendations for moving forward with specific steps to improve our structure and processes.

#### Goals:

- 1. Improve accountability, efficiency, and cost savings through possible consolidation and reorganization.
- 2. To have in place measurable objectives and performance measures throughout all County departments.
- 3. To improve the level of service among County departments, and to the citizens of Travis County.

Time is of the essence. Purchasing has indicated that an RFP would not be ready to issue till February or March of 2014, which would lead to an award possibly in May or June. This is too late. This should start before the FY15 budget process begins. We need to start as soon as possible to receive recommendations for specific steps to improve our structure and processes, which would help us in our FY15 budget discussions.

The recommendation is that Phase 1 be a sole source Professional Services Agreement, so the review & evaluation could begin at the earliest possible time (early January of 2014 at the latest).

2012. Dr. Richard Gambitta served as Director of the Institute for Law and Public Affairs (ILPA) at the University of Texas at San Antonio, retiring in 2011. At UTSA, he had served also as Chair of the Department of Political Science and Geography, Interim Chair of the Department of Sociology, Coordinator of the Master of Public Administration Program, Graduate Advisor of Record, and taught constitutional law, civil rights and liberties, law and society, public policy and administration, and ethics, as well as American and Texas politics courses across thirty years. He received his M.A. and Ph.D. in political science from the Maxwell School of Citizenship and Public Affairs of Syracuse University, with specializations in public law and public administration. He co-founded and directed the lauded UTSA Summer Law School Preparation Academy that has contributed to increasing significantly the number of UTSA, minority, and under-represented students attending and

excelling in law schools across the nation—with recent students attending Arizona State, Boston U, UC-Berkeley, Columbia, Emory, Georgetown, Harvard, KY, NYU, OK, Syracuse, Wake Forrest, Washington U., Wisconsin, U of Texas, all nine law schools in Texas, and many others, Fifty ILPA students were admitted during the year last recorded preceding his retirement and over 160 law schools have admitted his students. Numerous Dr. G. students have received PhDs. Dr. G. also co-founded the UTSA "McClendon" Legislative Scholars Program that awards \$10k to 10 selected students who are then placed with Members of the TX House of Representatives, including in the Speaker's Office. Also, Dr. Gambitta served as UTSA's Pre-law Advisor and directed the Legal Studies Minor.

In 2009, Gambitta won the University of Texas Regents Award for Outstanding Teaching the first year it was awarded, which provided a \$30,000 honorarium. In 2011, he won the Richard S. Howe Excellence in Service to Undergraduates Award, endowed by Edith McAllister, as well as the UTSA President's Distinguished Achievement Award for Excellence in University Service. In November of 2011, the Carnegie Foundation for the Advancement of Teaching and the CASE (Council for the Advancement and Support of Education) honored him as one of twenty-seven U.S. Professors of the Year nationally and named him the 2011 Texas Professor of the Year, see <a href="http://utsa.edu/today/2011/11/gambittacase.html">http://utsa.edu/today/2011/11/gambittacase.html</a>.

Dr. Gambitta was the first Fulbright Scholar at Chinese University of Hong Kong, during the time of the Joint Declaration. He taught public administration and policy at CUHK's Union College at the graduate and undergraduate levels. He has served as a National Endowment for the Humanities (NEH) Faculty Fellow conducting research as a visiting scholar at the University of Wisconsin and the U.S. Supreme Court. Gambitta was named a Piper Professor by the Minnie Stevens Piper Foundation in 1989 for distinguished teaching and "outstanding scholarly and academic achievement" selected from among 100 Texas colleges and universities. He served as a New York University Summer Fellow at NYU Law School, studying with legendary professor Derrick Bell. In 2007, Dr. Gambitta won: (a) the University of Texas System Chancellor's Council Award for Outstanding Teaching and (b) the UTSA President's Distinguished Achievement Award for Teaching Excellence, winning both of these awards for an unprecedented second time. He has won his College Dean's Award for Outstanding Teaching at both the undergraduate and graduate levels, the University Life Award twice as Outstanding Faculty Member, chosen by UTSA students, and the Amber Award three times for outstanding mentoring including in 2010. Dr. Gambitta has taught for the University of the Incarnate Word, St. Mary's University, and Syracuse University.

During recent years, Dr. Gambitta has received numerous civic awards including the LULAC National Education Service Centers' "Education Award for Outstanding Service" and the Liberty Bell Award from the San Antonio Young Lawyers Association. He has won many grants for his Institute students including those from the Texas Bar Foundation, ten from the Law School Admissions Council, and the Bexar County Federal Bar Association. His community awards include the Frederick Douglass Award for enhancing opportunities for African Americans, see recent press article regarding service to Blacks at http://www.mysanantonio.com/default/article/Former-UTSA-law-director-aided-blacks-2966946.php. He has also won: (a) Bexar County's Hidalgo designation for distinguished service; (b) the Distinguished Doctors Award by the Westside Chamber of Commerce and the Special Distinction honor by the Hispanic Chamber; (c) the Spirit of Education Award by the Texas Chicano Law Students Association; (d) the ACLU's Humanitarian Award; (e) the Distinguished Service commendation from Goodwill Industries; and many others. He has won innumerable university awards, appeared in many Who's Who editions (Executives, Teachers, America, World, etc.), and was selected by students to deliver the commencement address for the Honors UTSA College graduation, twice. He has given many keynote addresses including recently to a national American Fulbright Scholars Meeting, the SA Business Journal's 100 Top Businesses Luncheon, & the Bexar Co. Coalition of School Boards and Administrators. He has moderated debates between electoral candidates at the federal, state, and local levels including those for the Hispanic Chamber of Commerce; been a frequent contributor (over twelve times) to Leadership San Antonio education panels; taught for the Hispanic Association of Colleges and Universities programs; and hosted for years the First Friday Forums that discussed major issues confronting San Antonio; etc. He has spoken at hundreds of civic, educational, church, professional, and philanthropic meetings.

Dr. Gambitta serves presently and uniquely on two of the most significant public service boards in San Antonio and is committed to developing sustainable quality communities. He is a Commissioner of the San Antonio Housing Authority (SAHA), chairing its Operations and Human Resources Committees, contributed to policy-reform leadership in regional housing. Simultaneously, he serves on the Board of Trustees of the VIA Metropolitan Transit, serving on the operations and audit committees, and the Advanced Transportation District and Metropolitan Planning Organization's Transportation Policy Board. The President of the National Association of Housing and Redevelopment Officials appointed him to NAHRO's standing International Committee. His community commitments have included: the Board of Governors of the Good Shepherd Network of Catholic Schools (present), Chair of the City's Intra-City Rail and Streetcar Commission, Chair of the Board of Directors of Goodwill Industries of San Antonio, two-term president of his neighborhood association, director at the Education Investment Foundation, the advisory council to the Board Chair of the Hispanic Chamber of Commerce, member of the reform-oriented Mayor's Commission on Integrity and Trust in Government, the Community Alliance for Traffic Safety, & advisory board of the San Antonio Police Department's Training Academy.

Gambitta has presented research across Europe, Asia, and North America and his writings appear in diverse collections including: The Oxford Companion to the Supreme Court of the United States; Governing Through Courts (his coedited book); The Law and Policy Quarterly; The American Journal of Criminal Law; The Oxford Guide to Supreme Court Decisions; The Politics of San Antonio; Archiv für Rechts und Sozialphilosophie; The Politics of Judicial Reform, Rechtstheorie; the European Journal of Philosophy of Law, Philosophy and Computer Science; The Encyclopedia of the U.S. Supreme Court; South Texas Studies Journal; CLEO Edge (ABA); et al. and a chapter on the success of the SLSPA in Education Pipeline to the Professions: Programs that Work to Increase Diversity (2012).

Simultaneous with his professorships, Dr. Gambitta has engaged in the private sector in many capacities including ownership, CEO, research and policy consulting, strategic planning, logistics, and advising. He founded and directed the highly successful Gambitta Research Associates existing for twenty years 1981-2001, then disbanded it to avoid conflicts when assuming heavy administrative responsibilities at UTSA. Dr. Gambitta's clients have included forprofit and non-profit entities. He has conducted over twenty-five major survey research projects including for Clinton/Gore '92, KENS-TV, COPS [Communities Organized for Public Service], TxDOT, S A Light, the Archdiocese of San Antonio, etc. He was a consultant to KPMG for TexasOnline and to CNN/TBS. He has served as an advisor to elected officials at all three levels and in all three branches of government. He has served as a consultant to a host of candidates in both major parties including an Attorney General from Texas, Governor from Virginia, and Senator from New York. He has been an expert in federal and state cases on education finance, voting rights, and free speech. He has assisted with research for legal cases including jury selection, research, and expert testimony.

He has conducted many research studies and written many reports for government entities aimed at reform, including a three-volume *DWI Comprehensive Enforcement Project* (TxDOT grant & Bexar Co. D.A. Office), a bail bond reform study (BX Co. District Clerk's Office), a commission report on campaign finance reform for the Mayor & City Council of San Antonio, and significant studies for a host of other entities including the Archdiocese of San Antonio (on faith-based & public schools), television stations, newspapers, multi-media firms, private corporations, non profits, law firms, the Texas Trial Lawyers, etc.

The programs operated by OSM were top performers in the state and conducted several business process reengineering efforts for the Workforce Investment Act and the work component of Temporary Aid to Needy Families.
