AGENDA LANGUAGE: Consider and take appropriate action to accept a donation from Preservation Austin and Inherit Austin for interpretive and historic signage in Richard Moya Park in Precinct Four.

BACKGROUND/SUMMARY OF REQUEST:

The organization Preservation Austin and Inherit Austin held their annual Somewhere In Time Dinner on the Moore's Crossing Bridge at Richard Moya Park on Sunday, September 29, 2013. In appreciation for the use of the bridge for their dinner, Preservation Austin and Inherit Austin has submitted a check in the amount of \$1,000 for interpretive and historic signage in Richard Moya Park.

STAFF RECOMMENDATIONS:

ISSUES AND OPPORTUNITIES:

This donation would be used to place interpretive signage in Richard Moya Park to recognize the historic significance of the bridge and/or the park.




