**RE: Austin Independent School District Interlocal Agreement between  
Health and Human Services Healthy Families and County  
Attorney's Underage Drinking Prevention Program**

Healthy Families serves approximately 250 families per year through intensive home visiting services. They serve first time moms, and start seeing them prenatally until the baby is 3 years old. They outreach to certain high schools, but will serve teens from any school within AISD.

The Underage Drinking Prevention Program (UDPP) provides education to grades 4<sup>th</sup> – 12<sup>th</sup> on the legal and social consequences of underage drinking. This past school year, the UDPP conducted over 300 presentations for the Austin Independent School District.

**RENEWAL OF INTERLOCAL COOPERATION AGREEMENT**  
**BETWEEN TRAVIS COUNTY AND**  
**AUSTIN INDEPENDENT SCHOOL DISTRICT**  
**(Underage Drinking Prevention and Healthy Families Travis County Programs)**

This Renewal of written instrument ("2014-15 Renewal") is entered into by the following parties: Travis County, a political subdivision of the state of Texas ("County"), and Austin Independent School District ("AISD"), a state agency.

RECITALS

County entered into an Interlocal Agreement ("Agreement") with AISD to provide services to AISD students through the Underage Drinking Prevention and Healthy Families Travis Programs of Travis County, the Initial Term of which will end June 30, 2014 ("Initial Term").

The Agreement allows the Parties to renew the Agreement with written approval, and the Parties desire to renew the Agreement.

In consideration of the mutual benefits to be received through the following changes, County and AISD agree to change the Agreement as follows:

**1.0 RENEWAL TERM**

1.1 The Parties agree to renew the Agreement for an additional one-year term beginning July 1, 2014, and continuing through June 30, 2015 ("2014-15 Renewal Term").

**2.0 AGREEMENT PERFORMANCE**

2.1 **Services and Activities.** The Parties acknowledge and agree that each Party shall perform, in a satisfactory manner as determined by the Parties, services and activities in accordance with the terms and conditions stated in the Agreement.

2.2 **Insurance.** The Parties agree that the requirements for insurance for the 2014-15 Renewal will continue as set forth in the original Agreement.

2.3 **Debarment, Suspension and Other Responsibility Matters.** By signing this 2014-15 Renewal, each Party certifies that, to the best of its knowledge and belief, it and its principles continue to meet compliance requirements under 15 CFR Part 26, "Government-wide Debarment and Suspension" requirements as set forth in the Agreement.

2.4 **Certification and Warranty.** By signing this 2014-15 Renewal, the Parties certify that all certifications and warranties under the Agreement continue to be in full force and effect.

**3.0 INCORPORATION**

3.1 County and AISD hereby incorporate the Agreement into this 2014-15 Renewal. Except for the changes made in this 2014-15 Renewal, County and AISD hereby ratify all the terms and conditions of the Agreement. The Agreement with the changes made in this 2014-15 Renewal constitutes the entire agreement between the Parties and supersedes any prior undertaking or written or oral agreements or representations between the Parties.

3.2 The Parties agree that all requirements and obligations of the Agreement which have not been specifically changed by this 2014-15 Renewal remain in full force and effect and apply to performance by the Parties during the 2014-15 Renewal Term of the Agreement as amended.

**4.0 EFFECTIVE DATE**

4.1 This 2014-15 Renewal is effective July 1, 2014, when it is approved and signed by both Parties. This Agreement shall remain in effect until further modified or terminated in writing by the Parties, or until the termination date.
