Agenda Language: Approve Modification No. 1 to Interlocal Agreement No. 440001950, Capital Area Council of Governments for Orthoimagery Services.

- **Purchasing Recommendation and Comments:** Purchasing concurs with department and recommends approval of requested action. This procurement action meets the compliance requirements as outlined by the statutes.

Travis County Transportation and Natural Resources (TNR) request entering into an Interlocal Agreement with The Capital Area Council of Governments (CAPCOG) to acquire a 4-Band CIR (color infrared) leaf-on 12 inch resolution orthoimagery.

Aerial photography is an efficient means to assess changes to features within the county, taking into account the large geographic extent of the region. The County uses aerial imagery for many purposes: evaluating vegetation both in relation to fire damage and drought stress, determining impervious surface for drainage facilities, land use classification, rectification of parcel boundaries, digitizing structures, locating streets, bridges and other identifiable features, as well as a background for most of the mapping (including 911 addressing) and engineering projects in the county. Ortho-photography is particularly beneficial with Geographic Information System (GIS) software which makes viewing, analyzing and printing customized digital maps much easier.

This Modification No. 1 will extend the Termination of the contract until the total value of funding has been furnished or on March 30, 2015.

This modification will provide additional time to complete the services

being provided and does not impact the not-to-exceed amount of \$21,173.59.


Pursuant to Article 10 of this agreement, Article 4.1 Effective Date and Term of Contract is hereby deleted in its entirety and replaced as follows:
