The previous Motion died.

**Motion by** Commissioner Biscoe to table the adoption of the budget and elected officials' salaries for 7 days until October 7, 1997.

There was not a second on the Motion.

**Clerk's Note:** Judge Aleshire requested that Commissioner Biscoe table the previous Motion until Motions are made concerning other Items. Commissioner Biscoe agreed.

The previous Motion became a Tabled Motion.

Clerk's Note: The Court did not take a Vote on the Tabled Motion at this time.

Motion by Judge Aleshire that the following cuts and additions be made to the proposed budget (concerning his memo, Items 5, 6, 7, 8, 9, and 10): 5) A savings of \$87,873.00. That the additional three (3) full-time employees added to TNR for subdivision plat review be cut from the budget. Continuing to have the County review plats inside major city ETJ's is a blatant duplication of effort by the County and City Governments and an unnecessary expense to the property taxpayers, especially now that developers are not paying fees to Travis County for subdivision and development permit reviews. The result of not getting legislation to authorize the County to charge developers for these fees, as we've done in the past, was to transfer \$688,967, previously paid by developers only, to be paid by the general property taxpayers instead. The more efficient way to speed up the review of plats is to end the unnecessary duplication between the County and the Cities, not to add even more (in this case three more) County employees and additional costs for property taxpayers. 6) A savings of \$45,442.00. That the new position added to TNR for a "parks Recreation/Education Coordinator" be cut from the budget. Nature programs are already available from private and other public organizations. The public does not need another full-time County employee added to the County's payroll for such a non-fundamental position, especially in a year in which the revenue estimate for park fees is declining by over \$81,000.00. Creating this position contradicts the basic direction to take care of the fundamentals in our parks first. If this is truly a necessary position it could be funded with the money for the two parks maintenance workers which were added to the FY 97 budget for the Springbrook soccer complex which has not and will not open. 7) A savings of \$26,188.00. That the additional "personnel clerk" added as a new position for the Sheriff's Office be cut from the budget and instead a personnel clerk be transferred to the Sheriff's Office from TNR. In the Sheriff's budget request, she showed that the ratio of number of employees to the number of personnel clerks for her office was 223 employees per clerk, compared to 74 employees per clerk at TNR. The Sheriff currently has 1,116 employees served by five (5) personnel clerks, and TNR has 407 employees served by 5.5 personnel clerks. Transferring the personnel clerk from TNR to the Sheriff would make the employee/clerk ratio in the Sheriff's Office 186 and in TNR 90 employees per clerk. 8) A savings of \$100,000.00. Reduce the County Clerk's budget for Travis County's cost of the November election by the amount that will be charged to the City of Austin for joint election administration. 9) An addition to the budget of \$136,137.00. That an additional amount be included in the Sheriff's budget to lease space and provide necessary equipment for the first Sheriff's Satellite Substation. This would allow an actual first step in supporting the Sheriff's idea to physically locate offices closer to their customers in the unincorporated areas of Travis County, and thereby relieve office crowding and parking shortage in the downtown area. 10) A savings of \$13,570.00. If the Court adopts these items (5-9), the Unallocated Reserve will be reduced by 11% net savings.

There was not a second on the Motion.
