2. DISCUSS, PROVIDE INPUT AND DIRECTION REGARDING THE PURCHASE OF HEALTH AND HUMAN SERVICES FOR THE 1998 CALENDAR YEAR, AND TAKE APPROPRIATE ACTION. (1:48 PM)

Motion by Commissioner Biscoe and **seconded by** Commissioner Gómez that the graduates of the Community Justice Center (CJC) be provided in contract language, housing, job training and placement assistance, and substance abuse services, and that the child care training collaborative be funded in some way and probably expanded. The Court has been talking about child care training and income for the child care providers, but the Court definitely feels that the training is very important and should be funded.

A Clarification of the previous Motion was made by Commissioner Sonleitner that the Court will continue review to see if this type of collaboration is being covered by another entity. Although the Court feels that the CJC collaboratives are not being provided but the child care collaboration training may be.

An Additional Clarification was made of the previous Motion by Commissioner Biscoe that the Court is aware of 18 or 19 appeals that have been filed and will wait for the outcome of those appeals.

ITEM 2 CONTINUED

Second accept the Friendly Amendment by Commissioner Biscoe that the Court should indicate, along with the City of Austin (if they will join the Court), that this money is being spent to purchase these services, and gaps that are left should be identified as quickly as possible. The Court urges the partners to help them locate resources, as soon as possible, to assist in covering the gaps which are identified.

Acceptance of the Friendly Amendment was made by Commissioner Gómez.

A Clarification of the previous Friendly Amendment was made by Judge Aleshire that the Court does not just mean Government. The idea is to identify those gaps and have the Community Action Network (CAN) partners see what they can do, and whether they can help fill in where the Court was not able to provide all funding.

Maker and Second accept the Friendly Amendment by Judge Aleshire that as a matter of process, next year the Court wants to see this application and award process more closely supervised by the County Purchasing Office.
