1) Ask staff to come back to the Commissioners' Court with a project organization and options that would recognize that the Del Valle project would best be handled as a single project, using both the 1997 bond money and the 1993 bond money plus the supplemental amounts for the telecommunications and drainage issues. 2) Staff should include, in those recommendations, the best way to proceed in terms of putting together the AE contract (or contracts) to appropriately handle that as a single project. 3) As an additional matter, but separate, an issue about the project management and Travis County's relationship with Fluor Daniel.

4) Issue #1 - Approve the proposed program variances, which were outlined in the Item's discussion today. Issue #2 - Approve the cost estimates but <u>not</u> to approve the Items listed as alternates to be bid as alternates but to instead be bid as part of one base bid package. Issue #3 - Agree to the multiple bid release (the two-part bid release) basically for ground versus building. Issue #3a - Reiterate and reaffirm the Court's commitment to the multiple prime contracting method as opposed to the single prime contractor. Issue #4 - Take no action but to simply note that the project is staying on schedule. Issue #5 - Approve the Design Development Package. Issue #6a - Indicate interest in including the underground site distribution conduits.

Issue #6b - Indicate to the Purchasing Office the Court's interest in adding a contract modification for an amount not to exceed \$5,000.00, with Pfluger, Wiginton, Hooker/NBBJ for design services on the central control for security electronics infrastructure.

Issue #7a and b – Ask Purchasing to prepare an additional contract modification with Pfluger, Wiginton, Hooker/NBBJ for an amount not to exceed \$30,000.00, for the design of the construction documents, for an additional 24 medical beds that were discussed today. The Court also indicates that the construction budget be adjusted to include those additional beds (adjusted from the 5 to 24). The Court asks that all necessary contracts be brought back for approval as soon as possible.
