PBO will do the research on the list, but the important thing would be to have a cut off and say the Commissioners' Court will consider rolling over things that are on that list for pre-encumbrances. But if there are any other pre-encumbrances in the system that are not on that list, it should be assumed that they won't be rolled over. The things that are on that list would be submitted to PBO for their review and would be looked at by age, and by type. One of the other ways to limit this, and determine if there could be some benefit, is not in the Bond Funds, only in the General Fund and the Road and Bridge Area. There's no net gain in the Bond Funds (that will roll no matter what), just in the General Fund and the Road and Bridge Fund. Those would be reviewed and a recommendation would be made to the Court as to whether to roll all those over or only some of them before we adopt a Budget. In terms of general instruction, the intent of the Court is that whatever money is freed up should land in the Allocated Reserve.
