Between now and then a transition team would be put together to work out all administrative issues related to the reinstating of the parking fee effective January 1, 1999. Their tasks would include but would not be limited to: doing a complete audit of all parking spaces; coming up with suggestions and solutions related to parking sharing; assessing the number of slots that are there for County vehicles; and cleaning up and presenting the parking policy and procedures which exist. The Court must look to any legislative changes needed related to payroll deduction for leased spaces. It needs to be made clear that this is a dedicated fee that can be used only for parking purposes, and that the estimates be turned into the Auditor for potential certification related to the \$75,000.00 that the taxpayers now spend for leasing spaces in the downtown area. This committee would look at any extra ideas about decentralization and getting more vehicles out of the downtown area, and offer solutions and partnerships that can involve Capital Metro, related to van pooling and other kinds of ride solutions. This fee would not be automatically renewed year to year. The Commissioners' Court will review the parking policy on an annual basis. This does include take home vehicles in terms of who would be charged. Elected and Appointed Officials would also be paying for their parking spaces.
