The Motion was reworded by Commissioner Sonleitner to basically give Staff instructions that over the next week, we bring back the appropriate paperwork so that we can award this contract next week, and that we identify the appropriate line items to make up the differential, assuming, also, the savings from the Water Quality Project, so that we can award this next week; and that we spend our time and energy filling the budget gap, as opposed to what I think is wasted effort, in terms of instructions to redesign, and lose even more precious time.
