Maker and Second accept the Friendly Amendment by Commissioner Baxter to amend the resolution to read "Whereas recent air quality test results in Travis County failed current National Health Standards for ozone". So, after "failed", and before "national", my amendment would be that we insert the word "current".

Acceptance of the previous Amendment was made by Judge Biscoe and seconded by Commissioner Davis.

#### ITEM 1 CONTINUED

**Motion by** Commissioner Baxter **and seconded by** Commissioner Sonleitner to offer an amendment that would say, "Whereas, Alcoa, and other area power generators burn fossil fuels which, if not properly controlled using approved technologies, can impact ozone non-attainment; and whereas some of these power generating facilities are grandfathered and contribute in varying levels to the air quality in Travis County". That's the first part of the amendment. The second part of the amendment; go to the second paragraph in the most current draft, add after "emissions", "especially regarding lignite coal emissions, and emissions that contribute to ozone non-attainment."

A Clarification of the previous Motion was made by Commissioner Baxter to strike the 5<sup>th</sup> paragraph of the most current draft, and substitute the 6<sup>th</sup> paragraph in the other resolution. But, include after "impact", and before "and", the words "ozone non-attainment", strike "air quality", and put "ozone non-attainment" in that 5<sup>th</sup> paragraph. So, striking the 5<sup>th</sup> paragraph, substituting that 6<sup>th</sup> paragraph with that change; the rest of that amendment would be, in the second to the last paragraph, after the word "emissions" add "especially regarding lignite coal emissions, and emissions that contribute to ozone non-attainment".
