We basically would leave the Sheriff's budget at this place, after this cut, for fiscal year 2004.

**Clerk's Note:** A Clarification was made by Christian Smith, Executive Manager, PBO that \$731,420.00 is on-going out of the Sheriff's operating budget and \$284,000.00 is one-time expenses and that would be out of the CAR budget.
