- 5) That the court otherwise try to expedite acquisition of furniture, office equipment, space etc.; that in the meantime we secure appropriate temporary furniture, equipment and space to enable the Ms. Kinard to begin working, and;
- 6) Before that all becomes effective, Jim Connolly, Assistant County Attorney will arrange for one of the District or County Court-at-Law Judges to sign off on an order to help this as condition of this employment.
