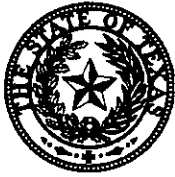

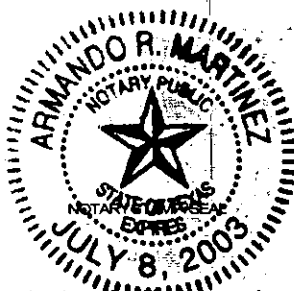

Please consider this explanation as a bona fide request for leniency as regards to any potential penalties.


