For July 15, 2009 Report


The July 15, 2009 Report has been corrected because six (6) expenditure checks were not reported due to an oversight by the Ron Davis' Campaign Treasurer, Louis Simms. Those six (6) checks increased the expenditures \$5,146.57.

The total political expenditures will increase from \$4,951.16 to \$10,097.73. The total political contributions maintained will decrease from \$64,425.48 to \$59,278.75. The Report Total Sheet and the Schedule F in this report reflects those changes.


