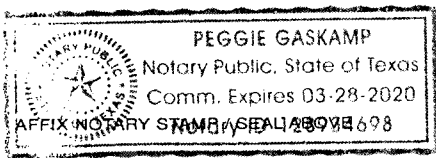

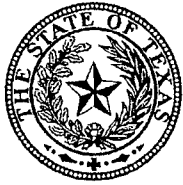

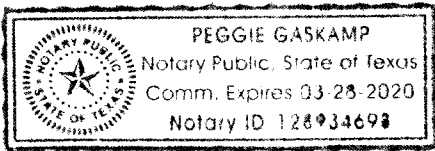

These reports are required to be filed electronically unless the person is eligible to claim the statutory exemption.*

*An entity filing a direct campaign expenditure report that has made more than \$20,000 in direct campaign expenditures in any calendar year must file all subsequent reports electronically.*
